NOTIFICATION

No. JSERC/27/SAC-303--In exercise of the power conferred on it under Section 181 (1) of the Electricity Act 2003 and all other powers enabling in this behalf, the Jharkhand State Electricity Regulatory Commission hereby makes the following amendment to the Regulation :

1. Short title and commencement : This shall be called Jharkhand State Electricity Regulatory Commission (State Advisory Committee) First Amendment Regulation 2006.
2. They shall come into force from the date of publication in official gazette.
3. They extend to the State of Jharkhand.
4. The words and expressions occurring in this order and not specially defined herein shall bear the meaning as in the Electricity Act, 2003.
5. The following amendment to the Regulation 11(2) of the JSERC (State Advisory Committee) Regulation 2003 is hereby made :

Amendment to Regulation 11 (2) : A sitting fee of Rs. 1,000/- (Rupees One thousand only) per meeting shall be payable to all the members of the Committee except the ex-officio members.
