Terms and Conditions for the Engagement of Empanelled Advocate(s) on behalf of the Commission and Regulations of their Fee (First Amendment)

Notification No. 119 --In exercise of power conferred on it under Section 181 Electricity Act,2003 read with Regulation 12 of JSERC (Conduct of Business) Regulation 2011 and all power enabling it in that behalf, the Jharkhand Electricity Regulatory Commission hereby makes the first amendment in Jharkhand State Electricity Regulatory Commission (Empanelment's of Advocate(s) and Payment of their fee) Order 2016(hereinafter referred to as the 'Principal Regulations').

1.Short Title and Commencement

- 1.1. These Regulations may be called the JSERC (Empanelment's of Advocate(s) and Payment of their fee) Order 2016 (First Amendment)2025.
- 1.2. These Regulations shall extend to the State of Jharkhand.
- 1.3. These Regulations shall come into force after its publication in the official gazette of the Government of Jharkhand.
