NOTICE

Applications are invited for appointment to the post of Chairperson-cum-Member (Legal) in Consumer Grievance Redressal Forums of the following distribution licensees to be posted at the places indicated against each:-

- (i) Jharkhand State Electricity Board (JSEB) to be posted at **Dumka, Hazaribagh, Medninagar and Chaibasa;**
 - (ii) Jamshedpur Utilities & Services Company Limited (JUSCO) to be posted at **Jamshedpur;** and
 - (iii) Steel Authority of India Limited (SAIL) to be posted at **Bokaro Steel City.**
1. As per the provisions of Electricity Act 2003 and JSERC (Guidelines for Establishment of Forum for Redressal of Grievances of Consumers and Electricity Ombudsman) Regulations 2005, the Jharkhand State Electricity Regulatory Commission requires the services of retired District/Additional District Judge for appointment to the post of **Chairperson-cum-Member (Legal)** in the Consumer Grievance Redressal Forums of the aforementioned distribution licensees for posting at the places indicated above against each licensees. The applicant should possess the following qualifications and experience:
- a) The candidate shall have not less than 25 years of experience in the relevant field having held the post of atleast District/Additional District Judge.
 - b) The candidate shall be persons of ability, integrity and standing who have adequate knowledge of and have shown capacity in dealing with the problems relating to Finance/Administration/Law.
 - c) Desirable to have experience of working in Consumers' Grievance Redressal system;

- d) The minimum age of the candidate to be considered for appointment as Chairperson-cum-Member (Legal) shall be **50 years** as on **31st October 2011**.
2. The Chairperson-cum-Member (Legal) shall be appointed on whole time basis to discharge exclusively the function of the Chairperson-cum-Member (Legal) and he shall not hold any other post or undertake any other work.
 3. The tenure of the Chairperson-cum-Member (Legal) shall be five years or 65 years of age, whichever is earlier.
 4. The Chairperson-cum-Member (Legal) will be paid honorarium equivalent to his last pay drawn minus pension.
 5. The candidates will have to furnish the following information through their employer organization in which they are/were serving along with NOC together with the following documents/information latest by **31st October 2011**.
 - a) Up-to-date and complete ACR (atleast for last 5 years);
 - b) Vigilance clearance certificate.
 - c) (i) Whether any penalty has been imposed on the applicant in the past;
 - (ii) If so, give details;
 - (iii) Indicate if any penalty is in operation against the applicant as on date.
 6. The candidates can apply directly to the undersigned on or before **31st October 2011** along with full bio-data and copy of degree on the basis of which he is applying.
 7. The second copy of the application should be sent to the undersigned through the employer/last employer on or before **31st October 2011** with the above mentioned papers.
 8. The crucial date for determination of eligibility of applicants for the post of Chairperson-cum-Member (Legal) will be **31st October 2011**.
 9. The application should be sent to the undersigned indicating the choice for places of posting in order of preference.
