DVC's responses to the Respondents' objections raised at JSERC Hearing dated 17.08.2020 and 18.08.2020 regarding truing-up for FY 17-18 and FY 18-19, APR for FY 19-20 and ARR for FY 20-21 for DVC's distribution and retail supply activity in the State of Jharkhand

A. Responses to objections raised by Mr. V.P.Singh representing TSUISL:

1. Objection: Hon'ble JSERC to direct DVC to consider RPO of TSL and TSUISL while computing DVC's RPO requirements.

DVC's reply:

- i. While computing the RE purchase requirements to fulfil RPO, DVC deducts firm sale to all licensees and applies the % RPO target on the firm energy sale to retail consumers only.
- ii. Licensee sales are deducted by DVC for RPO computation, because otherwise RPO will be charged twice on same energy which will increase the retail tariff.
- iii. Hon'ble JSERC in its past orders has approved DVC's approach of RPO computation (para 6.59 – 6.63 of order dt. 28.05.2019).
- iv. DVC follows similar approach while submitting yearly fulfilment of its Renewable Purchase Obligation (RPO) before the Hon'ble WBERC in respect of distribution activity in the West Bengal part of DVC also.
