**Office Report**

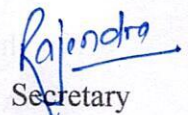
The petition dated 28.05.2024 for True-up of second control period FY 2016-17 to FY 2020-21 of the petitioner - Tenughat Vidyut Nigam Limited (TVNL) for 2x210 MW Tenughat TPS have been scrutinized and several deficiencies/discrepancies have been found in the petition as indicated below:

**Data Gaps/ Discrepancy Note on the True-up for FY 2016-17 to FY 2020-21  
Petition filed by Tenughat Vidyut Nigam Ltd. (TVNL).**

1. The Petitioner is directed to provide duly certified copy by the auditor certifying the Operational Parameters.
2. The Petitioner is directed to submit a Plant availability factor duly certified by the SLDC for the period FY 2016-17 to FY 2020-21.
3. The Commission has observed that during FY 2016-17 to FY 2020-21 the overall PAF & PLF of the plant is quite low than that approved by the Commission in the respective MYT order. In this regard the Petitioner is directed to provide justification against the same.
4. The petitioner is directed to submit the copy of the monthly bill raised to beneficiary for FY 2016-17 to FY 2020-21.
5. The Petitioner is directed to submit the audited certificate of GCV of primary and secondary fuel for FY 2016-17 to FY 2020-21.
6. The Petitioner is directed to submit the justification regarding higher auxiliary consumption for FY 2016-17 to FY 2020-21 comparative to MYT value approved by the Commission i.e 9.50%.
7. The Petitioner is directed to submit the proper justification regarding higher station heat rate for FY 2020-21 comparative to MYT value approved by the Commission.
8. The Petitioner is directed to submit the proper justification regarding higher side of secondary fuel oil consumption for FY 2016-17 to FY 2020-21 comparative to MYT value approved by the Commission.



9. The Petitioner is directed to submit the justification regarding the deviation in the price of primary fuel and secondary fuel for FY 2016-17 to FY 2020-21 with respect to the audited accounts submitted by the petitioner. In this regard the Petitioner is directed to provide break up of cost considered.
10. The Petitioner is directed to submit justification regarding the steep increase of Employee expense for FY 2016-17 to FY 2020-21.
11. The Commission has observed that the Petitioner in R&M expenses has claimed amount pertaining under the head as "others". In this regard the petitioner is directed to provide details of such expense.
12. The Petitioner is directed to provide details and nature of capitalization of assets which has been considered in equity addition.
13. The Petitioner is directed to submit the methodology used for calculation towards depreciation submitted in the final true up for FY 2016-17 to FY 2020-21.
14. The Petitioner is directed to provide documentary evidence regarding actual ash disposal expenses for FY 2016-17 to FY 2020-21.
15. The Petitioner is directed to provide documentary evidence of the actual water expense for FY 2016-17 to FY 2020-21.
16. The Commission has observed that the Petitioner has not provided any update on the status of directives issued by the Commission in the earlier orders. In this regard the Petitioner is directed to provide compliance status of the same.
